On Saturday, April 18th, SHORE's 2009 Spring Benefit called "Heroes Among Us" was held at the North Shore Country Club in Glenview. The honoree was Paul Cirigliano of Panoptic Studios, Inc. Mr. Joseph Koenig, Jr. of Trim-Tex Inc. presented Mr. Cirigliano with the Thomas & Lois Lloyd Humanitarian Award, which is named for the agency's founders. Mr. Cirigliano is the President of Panoptic Studios, Inc., which is a film, video, interactive motion graphics, and web site production company in Wauconda. SHORE's new agency video and re-designed website were produced by this company at no cost to the agency.

Nearly 150 people enjoyed cocktails and hors d'oeuvres, dinner and entertainment by "The Naturals," which is a local musical group that has two members who are autistic. Everyone loved the entertainment and many guests even got up to dance. There were Silent and Live Auctions and a game called "Heads or Tails" was played and the grand prize was a 42" Panasonic Plasma television. Over \$56,000 was realized from the event. All proceeds will be used to enhance SHORE's programs and services to nearly 400 children and adults with developmental disabilities.

CARF Accreditation Awarded to SHORE

SHORE has recently been notified that it has been accredited by CARF (Commission on Accreditation of Rehabilitation Facilities), which is an international accrediting agency, for a period of three years for the following services:

Community Services: Community Integration

**Employment Services: Community Employment Services: Job Development
Employment Services: Community Employment Services Job Supports
Employment Services: Community Employment Services: Job-Site Training
Employment Services: Organizational Employment Services**

This accreditation will extend through April 2012, and it marks the 13th consecutive three-year accreditation SHORE has received from this prestigious organization. The achievement is an indication of SHORE's dedication and commitment to improving the quality of the lives of the persons served. CARF surveyors made no recommendations, which signifies that they did not identify any areas of nonconformance to the standards. This is an extraordinary accomplishment, as only three percent of CARF surveys result in no recommendations.

Here is a summary of what the survey stated, "SHORE Community Services has a dedicated, principled, and committed staff whose efforts on behalf of clients were clearly evident throughout the survey. Staff members are well qualified, credentialed and dedicated to providing the clients with high quality services and meaningful experiences. The longevity of staff is also worthy of note. The agency provides safe and healthy environments for work and service provision. The mission, vision, values and ethical codes are used as the foundation for what is an amicable and effective corporate structure and culture. The administration has created and reinforced an organizational culture that is value laden and true to the agency's mission."



Legislative Update – Community Providers Cannot Endure any Cuts to Services and Supports for Individuals with Developmental Disabilities

It is imperative that you call your State Representative in his/her Springfield Office and tell him/her that any cuts to programs for individuals with developmental disabilities would be very harmful. You will probably be giving your message to an assistant. Be sure to leave your name and contact information and request a return call.

Inform the State Representative or his/her assistant that cuts from the budget for Community Providers such as SHORE will result in reductions in staff and the closing of programs, which will have a very serious impact on persons served by the agency. The workloads of staff will increase, facilities will close and clients will be sitting at home.

All supporters of SHORE must do their utmost to convey the message that The Governor's Doomsday Budget will be a disaster for SHORE and that the agency will not be

able to sustain its current level of programming for the nearly 400 individuals it serves with developmental disabilities.

Let the State Representative know you support an increase in taxes if it includes restoration of cuts and increased funds for Community Providers of services and programs for individuals with developmental disabilities.

Annual Appeal Update & Other Grants

As of May 1st, the Annual Appeal Campaign has raised over \$105,700, surpassing the \$96,300 goal set by the Board of Directors by over \$9,000. This is an extraordinary result in light of the weak economic times. Three hundred fifty-five donors generously contributed to this campaign, which is the largest non-event fundraiser for the agency. All proceeds from the campaign are used to enhance the programs and services offered at SHORE to nearly 400 children and adults with developmental disabilities. The Appeal goes to the end of the fiscal year, which is June 30th, so it is not too late to send in a contribution. Other significant grants and gifts received during the fiscal year include: \$10,000 from the Evanston Community Foundation for bilingual developmental playgroups at the Early Intervention program, \$5,000 from the Colonel Stanley R. McNeil Foundation for playgroups at the same program; \$3,000 from Target for a Lending Library at the EI Program; \$4,000 from The Gabe W. Miller Foundation for additional social work services for the residents at SHORE Homes West in Skokie; \$10,000 from the Circle of Service Foundation for the Adult Services Program at the Lois Lloyd Center; over \$20,000 from the John & Alice Lloyd Foundation, \$10,000 from The Siragusa Foundation and \$7,500 from the Winnetka Congregational Church were received for general operating; and \$10,000 from the Morton Grove Foundation for SHORE Joseph Koenig, Sr. Training Center.

SHORE would also like to acknowledge the generosity of the Koenig Family Foundation. The foundation gave each person served and staff \$25.00 as a holiday gift and other significant donations were received, which were used for general operating needs.

Thank you to all those who helped support the Annual Appeal and to the foundations and others whose support enables SHORE to offer the highest quality programs and services.

DID YOU KNOW?

"People with Disabilities Ride Free Program" went into effect on October 24th? In late August, the former Governor Rod Blagojevich signed legislation (SB1920), which included an amendment providing free, fixed route, public transportation services to individuals with disabilities who meet the income requirements of the State's Circuit Breaker program.

The State of Illinois has issued postcards to persons with disabilities who were enrolled in the Circuit Breaker program during 2008. The postcards serve as proof of eligibility for the free ride benefit, however, please note that a local transit ID may still be required to ride.

Income eligibility limits and specific information pertaining to your region's transit provider can be found at www.illinois.gov/transit. Individuals with disabilities who are not eligible for Circuit Breaker still qualify for half-price transit rides as currently provided under law.

Larry - A Fine Success Story

Larry is a participant in the Adult Services Program at the Lois Lloyd Center in Evanston and has made great progress while at the center. Over the years, Larry resided at several CILA (Community Integrated Living Arrangement) programs and attended numerous Developmental Training programs. However, Larry's behavior always impeded his ability to reach his full potential. In December 2006, Larry moved into a new CILA program and started at the Adult Services Program in January 2007.

Through the cooperative efforts of the staff at the Adult Services Program and Larry's CILA program, Larry improved his appropriate behavior including remaining on task. After several months at the Adult Services Program, it was recommended that Larry start participating in training at SHORE's Joseph Koenig, Sr. Training Center. Larry has done a great job at the Training Center with assistance from the Adult Services staff. Larry stays focused on the work he is completing at the Training Center. He looks forward to going to the Center twice a week and receiving his pay check every other week.
